Dear Parent/Carer

In line with Government policy, the School Health Service is aiming to involve all children and their families in how health resources are effectively targeted in the future.

In order to achieve this, during this term your child will be involved in completing a simple online questionnaire about their health, wellbeing and lifestyle behaviour.

The questionnaire gathers the needs of children and young people as identified by them and offers an opportunity to provide intervention at an early stage. Information for the health needs assessment is collected via an online portal – HAPI (Health Awareness Prevention and Intervention) – that will help to identify any issues that may impact on the health and well-being of your child.

Once completed, the data is reviewed by Specialist Community Public Health Nurses (School Nurses) and your child may be seen at their own request or at the request of the School Health Team if required.

If your child has a special education need (s) and or disability, please contact your school nurse to discuss the suitability of questionnaire for your child and how we can best support them to complete if appropriate. The results of these questionnaires are looked at in conjunction with the child's health record and will not affect any support a child or young person receives in relation to their disability or diagnosis.

In addition, any emerging themes are used to tailor a bespoke public health plan for the school so that group health education sessions can be delivered.
